# Leaving a gift in your Will

Gifts in Wills provide vital income, so we can continue to deliver prevention services, including Nightstop emergency accommodation and family mediation support to keep families together. Our progression coaches work with young people to empower them to live independently. By providing support for managing their mental health, building healthy relationships and accessing education, training or employment, we can help young people realise their full potential. Your legacy will ensure young people will get the chance they deserve.

Many people choose to leave a gift that helps young people in our services, wherever the need is greatest. However, if you would like your gift to be used to support a particular service, you can specify this in your Will.

If this is something you wish to do, please contact **[julia.billington@depaulcharity.org.uk](mailto:julia.billington@depaulcharity.org.uk)** to discuss your intentions and ensure that your wishes are met.

## Legal considerations

Please also ensure that you refer to your financial or legal advisor for advice on inheritance tax. Inheritance tax is not payable on charitable gifts and if you make a gift of 10% or more from your estate to charity, the inheritance tax liability can be reduced from 40% to 36%.

When it comes to writing your Will or updating your existing Will, we recommend you seek legal advice.

## Next steps

Your Will is a personal matter and we appreciate that family and friends come first. However, even leaving a small percentage of your estate could make a significant difference to the life of a young person experiencing homelessness.

On the following pages, you will find information about how to leave a gift in your Will to Depaul UK. We hope this will help you decide which type of gift is appropriate for your personal situation.

# Different ways to leave a gift in your Will

## RESIDUARY GIFT

This type of gift is a percentage share of your estate after tax, expenses, and all other gifts in your Will have been paid. You can leave the residue to one beneficiary or share it amongst several. All the other bequests will be settled before the residuary gifts are made. If you decide a residuary gift is right for you, here's an example of how your Will could be worded:

**'I give a X% share of the residue of my estate to Depaul UK (registered charity no. 802384) of Sherborne House, 34-36 Decima Street, London, SE1 4QQ for its general purposes.'**

## PECUNIARY GIFT

A pecuniary gift in your Will is a specified amount of money. You can leave any chosen sum. However, when making a gift of this kind it is worth taking inflation into consideration – either by reviewing your Will every few years, or index-linking your cash gifts (essentially, linking your gifts to the rate of inflation). Your solicitor will be able to advise how to do this. Here's an example of wording for a pecuniary gift:

**'I give the sum of [amount in figures and words] to Depaul UK (registered charity no. 802384) of Sherborne House, 34-36 Decima Street, London, SE1 4QQ for its general purposes.'**



## SPECIFIC GIFT

If you would like to leave a specific gift, such as a personal possession, land, building or shares, we would be incredibly grateful if you could please let us know, so that together we can agree the best means of looking after your gift.

With Bequeathed you can make a start on your **Will For Good** immediately. Just go online any time that suits you and follow the simple steps to create your draft Will.

A member of staff from one of the Bequeathed partner legal firms will then advise you in a free 30-minute appointment, which can be by phone or video call, at home or in the office. They'll discuss your circumstances

and your wishes and confirm the Will fully caters for your needs.

Once your Will is complete, the firm will help you get it signed and witnessed, and store it for you, also at no cost.

# Why I'm leaving Depaul UK a gift in my Will

**After many years of helping young people experiencing homelessness through her support for Depaul UK, Trish Taylor decided to leave us a gift in her Will. Here she explains why:**

"I felt so sad for young people when in a lot of cases they are made homeless because they don't get on with their families. That could happen to anybody.

"I've done various things to support Depaul UK down the years. In the past, I used to raise funds through raffles, and I've donated bags of toiletries for young people. Three years ago, I did a sponsored sleep out and raised nearly £1,000, and most recently I did the Weighted Walk with my granddaughter, who carried a rucksack for me.

"Because it has been important in my life, I wanted to leave something in my Will. My husband and I did a Will years ago but we really needed to update it. So I will provide for my son, my daughter and my grandchildren, and I have made a small gift to Depaul UK as well.

"It just breaks my heart to see young people suffering, and I know the money I leave will be helping them in the future."
